

W-8BEN Form Filling Instructions and Notes

Notices for Clients to complete the W-8BEN Form:

- The U.S. Internal Revenue Service (IRS) requires that non-U.S. individual Clients who need to pay taxes to the U.S. government file a W-8BEN Form.
- Purposes for submission of W-8BEN Form :
 - > Prove that the Client is not a U.S. Citizen or Person
 - > Confirm that the Client is a beneficial owner of dividend income
 - ➤ Capital gains derived from the sale and purchase of Securities, Bond and/or Fund by non-U.S. Citizens or Persons are exempt from any U.S. Tax, but dividends earned are subject to a 30% Withholding Tax
 - Applicable to residents of jurisdictions that have a tax treaty with the U.S. who request a reduction or exemption from Withholding Taxes:
- Who needs to file a W-8BEN Form :
 - ➤ Capital gains derived from the sale and purchase of Securities, Bond and/or Fund by non-U.S. Citizens or Persons are exempt from any U.S. Tax, but dividends earned are subject to a 30% Withholding Tax
- "Tax Treaty Benefit" means a tax deduction and exemption jurisdiction in which the Client resides in a jurisdiction of the U.S. If the Client is eligible for the tax treaty benefits, please complete the "Part II" section of W-8BEN Form. Please fill in the name of the Client's jurisdiction of residence (Please use full writing) in Paragraph 9 to apply for the "Tax Treaty Benefit", which must be the same as the jurisdiction in paragraph 3.
- Clients should seek their own professional advice on taxation, including but not limited to tax liabilities such as estate tax and ruin Withholding Tax that may be involved in making overseas investments.
- Clients may submit the completed W-8BEN Form through any of the following channels:
