## 實貨證券寄存注意事項 Physical Securities Deposit Attention

1. 客戶請於辦公時間內 (即星期一至星期五:上午9時至下午6時,公眾假期除外) 親臨華亞證券位於香港之辦公室領取實貨證券,地址為香港上環德輔道中199號無限極廣場21樓2101室。華亞證券「客戶服務部」會在收到實貨證券後直接致電客戶安排預約領取。Clients are requested to collect the Physical Securities from QMIS Securities Hong Kong office during office hours (i.e. Monday to Friday: 9:00 a.m. to 6:00 p.m., except public holidays) at Unit 2101, 21/F, Infinitus Plaza, 199 Des Voeux Road Central, Sheung Wan, Hong Kong. QMIS Securities "Customer Service" will directly call the Client after receiving the actual "Physical Securities" to arrange for collection.

- 2. 若客戶欲授權第三方代為領取實貨證券,該獲授權第三方必須帶同**客戶簽署的「授權書」正本**。

  If the Client wishes to authorize a Third Party to collect the Physical Securities on THE Client's behalf, the Authorized Third Party must bring with him/her the **Original "Authorized Letter" signed by the Client**.
- 3. <u>請注意</u>:客戶必須在收到華亞證券「客戶服務部」通知後 <u>48 小時內</u>領取實貨證券。期限過後,華亞證券會將未獲客戶領取的實貨證券放回中央結算系統,而已扣取的相關費用將不獲退回。

After the expiration of the period, QMIS Securities will put the Physical Securities that have not been claimed by the Client back into the CCASS, and the relevant fees deducted will not be refunded.
