Clients are requested to collect the Physical Securities from QMIS Securities Hong Kong office during office hours (i.e. Monday to Friday: 9:00 a.m. to 6:00 p.m., except public holidays) at Unit 2101, 21/F, Infinitus Plaza, 199 Des Voeux Road Central, Sheung Wan, Hong Kong. QMIS Securities "Customer Service" will directly call the Client after receiving the actual "Physical Securities" to arrange for collection.
